To be the collective voice of the funeral service regulatory community and promote excellence in regulation through the sharing of best practices and the facilitation of open dialogues across all jurisdictions.







### TESTING ACCOMMODATIONS PROCESS


The Conference is committed to the principle of testing individuals in a manner that will yield valid and reliable exam results. In some instances, the exam administration procedures may need to be modified to provide reasonable accommodations for candidates who qualify under the Americans with Disabilities Act (ADA).

In an effort to ensure the accommodations request process is easy to follow, The Conference publishes the ADA Testing Accommodations Handbook annually on its website. This handbook outlines who is eligible to receive testing accommodations while also providing detailed instructions on how to submit an accommodations request. Additionally, the handbook serves as a reference for exam candidates with disabilities and includes the Candidate Accommodations Request Form and the Health Practitioner Statement, which are submitted as part of the request. ### STUDY MATERIAL




The study guides published by The Conference assist in preparation for the National Board Exam (NBE) and the State Board Exam (SBE).

Each guide includes professional expectations, content outlines, sample questions, and glossary terms. Laws, Rules, and Regulations Exam study guides are an added feature The Conference is able to produce on behalf of a state. The above numbers reflect purchases in 2020.





The Practice National Board Exam (PNBE) and Practice State Board Exam – Arts (PSBE) provide a Realistic, timed exam experience featuring 75 multiple choice questions that are statistically representative of the number of questions in each subsection of the exam blueprint. At the conclusion of the practice exam, candidates receive a score report reflecting their performance and general feedback on content areas in which candidates answered items incorrectly. ### MODEL DOCUMENTS

The Conference Model Practice Act Review Committee conducted a full review of the Model Practice Act for Funeral Service (MPA) in 2020. The amended version will be presented for adoption on February 24 at the 117th Annual Meeting.

The purpose of the Model Act is to facilitate the protection of the public by providing legal mechanisms that establish and provide for the enforcement of uniform standards. To date, funeral service professionals from 24 jurisdictions have participated in the Conference Model Document series.

### MEMBERSHIP POLLING

The Conference conducts real-time polling on behalf of our membership throughout the year. Responses are collected and sent back to the inquiring board for analysis and review. During 2020, the following topics were addressed

### **SCHOLARSHIPS**

Each year The Conference Board of Directors awards 10 scholarships for the National Board Exam. Applicants submit a short essay on a range of topics and recipients are drawn at random during the Board of Directors spring and fall meetings. The topics for 2020 were on the importance of professional conduct as a student, examinee, and licensee, as well as the meaning of giving back to the funeral service profession. ### **CONTINUING EDUCATION**

The Conference awarded 33 certificates to licensees from 29 jurisdictions during the 116th Annual Meeting in Palm Coast, FL.

A total of 19 credit hours were possible during the event including Board Member Training. The Conference was pleased to be approved by 21 jurisdictions.

### **BOARD MEETINGS GO VIRTUAL**

The COVID-19 pandemic forced most regulatory board meetings to a virtual format in 2020. Conference staff had the opportunity to sit in on over 100 state and provincial meetings which allowed us to stay up to date on membership issues.

### VIRTUAL DISTRICT MEETINGS

Keeping an open line of communication has been of utmost importance to The Conference during the pandemic. Through seven virtual district meetings, The Conference hosted nearly 70 participants from across 31 jurisdictions to ensure dialogue continued across our membership regarding the updates in executive orders, regulation, and licensee needs.

### ITEM WRITING WORKSHOP

The Conference hosted its first virtual Item Writing training for funeral service licensees interested in volunteering their time and learning more about the National Board Exam development process. The workshop provides an overview of how the exam is constructed, with a primary focus on how to write items for a national licensure exam. Those who completed the training were invited to attend one of two virtual workshops held this summer. Licensees from 23 states participated in the workshops.

### **BOARD MEMBER TRAINING**

The Conference partnered with Legal Counsel, Dale Atkinson, to offer our Board Member Training program in person and virtually in 2020. - -The NBE consists of an Arts Exam and a Sciences Exam.

- -Must be made eligible by state (MD, OK, TN, TX are made eligible by school).
- -There is a SBE Arts Exam and SBE Sciences Exam (depending on state).
- -The SBE is NOT state-specific content.


### State Laws Exam (LRR)


- -Must be made eligible by state (not applicable for TN).
