

# **Board Mission: Arkansas**

• The mission of the Arkansas State Board of Embalmers and Funeral Directors is to act in the public interest, for the public protection and advancement of the profession within the police powers vested in the Board by the Legislature of the State of Arkansas, entirely without general revenue funds.



# Board Mission: Oregon

• The mission of the Board is to protect public health, safety and welfare by fairly and efficiently performing its licensing, inspection and enforcement duties; by promoting professional behavior and standards in all facets of the Oregon death care industry; and, by maintaining constructive relationships with licensees, those they serve and others with an interest in the Board's activities.

# **Board Mission: Arizona**

 ...Maintain and enforce a set of standards that provides protection for the health, safety, and welfare of Arizona citizens by educating the consumer and by actively and impartially regulating those licensed to provide funeral goods and services.

(From 2020 audit, could not locate on board website)





- Declared state of emergency
- Statutes authorize Governor the declare a state of emergency
- Once declared, Executive Branch powers are expanded during the state of emergency
- Authorization to suspend statutes and, effectively, create new laws temporarily and as needed to address the emergency.
- Limited time frame, limited authority
- Subject to checks and balances, separation of powers & litigation





- Via an executive order, cannot modify the statutes authorizing the Governor to declare a state of emergency.
- Declared state of emergency have a limited period
- Under separation of powers, the legislative branch is expected to enact laws as deemed necessary.
- Legislature may cancel the state of emergency as a means of addressing executive branch authority.





# COVID

- Executive Orders....force of law?
  - An executive order many be a directive from the Governor to state agencies, communicating to those agencies what the Governor wants the agency to accomplish. The order does not have the force and effect of law. However, compliance by state agency heads who serve at the pleasure of the Governor is normally expected. If such an agency head does not comply with the Governor's policy enunciated in the order, the Governor may decide to remove the agency head from office.

- Executive Orders-litigation
- Edwards v. Louisiana State Legislature: On October 26, 2020, Governor John Bel Edwards (D) filed suit in the 19th Judicial District Court, challenging a petition by members of the Louisiana House of Representatives that purported to terminate the governor's public health emergency proclamation and end Covid-19 restrictions in the state, including business occupancy limits, a statewide mask mandate, and guidelines for churches and schools. The petition, signed by 65 of the 73 House Republicans, was initiated under a state law allowing a majority of legislators in either chamber of the state legislature to sign a petition to unilaterally revoke an emergency declaration. After issuing the petition, the House of Representatives released a statement: "The House has exhausted every available legislative remedy and has been left with no other option but to exercise its legislative right to terminate the governor's emergency order." In his complaint, Edwards alleged that the petition was "an unconstitutional attempt by the members of one house of the Legislature—without bicameral action or presentment to the Governor—to unilaterally prohibit him from exercising his constitutional and statutory authority." Edwards also argued that the actions of the House "caused and will continue to cause confusion in the State of Louisiana regarding the enforceability of the Governor's proclamation."
